## NO PURCHASE NECESSARY TO ENTER OR TO WIN

**OFFICIAL RULES** 

VOID WHERE PROHIBITED BY LAW OR REGULATION.
THIS CONTEST IS OFFERED ONLY IN THE 50 STATES OF THE U.S. AND WASHINGTON, D.C. AND IS INTENDED FOR PARTICIPATION IN THOSE AREAS ONLY.

- 1. <u>Sponsor:</u> FTD, Inc., 3113 Woodcreek Drive, Downers Grove, Illinois 60515 ("Sponsor"). Although the FTD® 100moms Contest (the "Contest") is administered through a Facebook interface, the Contest is in no way sponsored, endorsed or administered by, or associated with, Facebook, Inc. ("Facebook"), though Facebook's terms of use apply to all use of Facebook. You are providing your information to Sponsor and not to Facebook.
- 2. <u>Eligibility:</u> The Contest is open only to permanent legal residents of the 50 United States and Washington, D.C. (excluding Guam, Puerto Rico and all other U.S. and foreign territories and possessions) who are physically located and residing therein and who warrant and represent that they meet all of the following requirements as of the time their entry into the Contest is deemed complete: (a) they are 21 years of age or older; (b) they have a Facebook account; (c) they have Internet access; (d) they possess a social security number, or federal tax identification number issued by the appropriate government agency at time of entry; and (e) they have carefully read and reviewed prior to agreeing to, and agreed to as instructed, the Contest Official Rules. The Contest begins at 9:00:01 a.m. Pacific Standard Time ("PST") on April 16, 2014 and ends at 11:59:59 p.m. PST on May 8, 2014 (the "Contest Period"). To enter this Contest, please access the Contest application at http://www.facebook.com/FTDFlowers and complete the entry process, including an essay of up to 100 words and uploading a photo or video (of less than 120 seconds) about your mom or another special mom in your family (whether mother, grandmother, great grandmother, aunt, sister, etc) Remember, originality and creativity are factors in the judging and submitting a photo or video is important to show your originality and creativity. You will be required to "Like" the FTD® Facebook fan page, found at http://www.facebook.com/FTDFlowers (if you are already a "Liker", you will not be required to complete this action). You may also be required to input your name and email address on a separate form page. The order of these steps may vary. These steps will enter you in the Contest. YOU MAY NOMINATE AS MANY "MOMS" AS YOU WOULD LIKE, BUT ONLY ONE ENTRY PER EMAIL ADDRESS AND NATURAL PERSON PER NOMINATED "MOM" IS ALLOWED DURING THE CONTEST PERIOD. Valid entries must be submitted via the online method as described above. All entries must be received during the Contest Period. Any attempt by an entrant to obtain more than the allowable entry by using multiple/different e-mail addresses or Facebook accounts, identities or any other online methods will void all of that entrant's entries. By entering, entrants agree to comply with these Official Rules including all eligibility requirements. Sponsor reserves the right to verify eligibility of all entrants. Illegible and/or incomplete entries and entries submitted by entrants who do not meet the

eligibility requirements (including all requirements with respect to age and residence) are void. Sponsor and their agents are not responsible for lost, late, or misdirected entries, for technical, hardware or software failures of any kind, for lost or unavailable network connections, or for failed, incomplete, garbled or delayed computer transmissions or any human error which may occur in the receipt or processing of the entries. Proof of entering information at website does not constitute proof of delivery or receipt. Sponsor reserves the right to modify the scheduling of the Contest without prior notification. Use of computer programs, macro, programmed, robotic, automatic and other similar means to enter the Contest is prohibited and may result in the disqualification of entries and/or the entrant. In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed to be submitted by the person in whose name the e-mail account is registered on the date the entry is submitted. Entries must be original, and all entries become the sole property of the Sponsor and will not be acknowledged or returned. Entry must be in keeping with the Sponsor's family friendly image and may not be offensive nor can it defame or invade upon the publicity rights or privacy of any person or otherwise infringe upon any person or entity's personal or proprietary rights, as determined by the judges in their sole discretion. ## 4. Winner Selection and Notification:

Each potential winner will be selected on or about May 12, 2014, by Sponsor or a designee, the judge of the Contest whose decisions are final and binding on all matters relating to the Contest and will be judged on the basis of: adherence to the best mom theme (30%), creativity of entry (35%), originality (35%). In the event of a tie, the entries involved will be re-judged according to the criteria listed above. (each a "Potential Winner"). Each winner will be notified through Facebook or by email (at the email address provided in the Contest entry) and provided the prize. If the prize cannot be delivered or is returned as undeliverable, the prize will be forfeited. Potential Winner forfeits the Prize. In the event that the Potential Winner does not comply with these Official Rules or is otherwise disqualified for any reason, Sponsor may award the applicable Prize to an alternate Potential Winner selected from among the other Contest entrants at its sole discretion. 5. <u>Prizes:</u> 100 prizes will be awarded. (\$50 FTD ® electronic gift cards) The Prize consists of the following: Approximate Retail Value ("ARV") \$50 USD. All terms and conditions of electronic gift card apply.

Odds of winning depend on the number of eligible Contest entries received during the Contest Period. If a Winner forfeits a Prize, this forfeiture will serve as complete fulfillment of the obligation by the Sponsor and no additional compensation will be awarded. Each Winner is solely responsible for all costs, incidentals, and any other expenses not specifically mentioned as being included.
